Dear Secretary Miller, Mr. Brown and members of the Commonwealth Transportation Board,

Chesterfield County

The Central Virginia Transportation Authority (CVTA) was formed in the summer of 2020 and has made considerable progress in less than two years of operation. Local leaders, thanks to your support in establishing the CVTA, have been able to accomplish the following tasks:

Goochland County

> Make a \$104 million commitment to development of the Fall Line, with cooperative funding of \$42 million secured through the Commonwealth Transportation Board

Hanover County

> 2. Advance critical local transportation needs, using the 50% local share, in all nine member jurisdictions

Henrico County

> 3. Approve annual regional public transportation plans for GRTC investment in regional transit intiatiatives using the 15% dedicated transit share

New Kent County

> 4. Program \$276 million in regional revenues to a slate of 30 projects that can be leveraged against other funding sources and be shovel-

One project that is a priority for CVTA members which cannot be addressed simply through our own funding mechanism is the need to widen the 29-mile gap on Interstate 64 from exit 205 in New Kent County to Exit 234 in James City County. This project is simply too large to address through only one means of funding. We are encouraged to hear Secretary Miller's remarks at the June 2, 2022 regional joint forum referencing the commitments of the State, Richmond and Hampton Roads as well as Federal grant opportunities.


project to reality.

Our understanding of the current funding opportunity is that through a combination of funds from all partners, funding of the project can be achieved this year. A distribution of available funding sources based on best available information is graphically shown below:



Please accept this letter as the CVTA's commitment to contribute \$100 million to the overall cost of the project and joining with other partners to make this critical piece of infrastructure a reality. This collective funding can be used as leverage in an effort to secure the remaining funds through Smart Scale or other resources. We look forward to working with VDOT to understand the cash flow needs for the project so we are able to plan when the funds will be needed.
